BOARD OF COUNTY COMMISSIONERS

FEBRUARY 21, 2023

A Strategic Focus Area Review Workshop was held at the Centennial Park Recreation Center, 1120 Centennial Boulevard, Port Charlotte, Florida.

The following members were present: Chair Truex, Commissioner Constance, Commissioner Deutsch, Commissioner Doherty, and Commissioner Tiseo. Also in attendance were: County Administrator Flores, County Attorney Knowlton (arrived at 9:29 am), Minutes Clerk Johnston, and various County staff members. The following members were absent: None.

The Meeting was called to order at 9:00 am, followed by the Pledge of Allegiance.

County Administrator Flores highlighted Strategic Focus Area Review and introduced Dr. Herb Marlowe, Analytica Founder.

1. Review of Strategic Planning Process

Gordon Burger, Budget and Administrative Services Director gave a brief overview of Agenda, Stages of the Budget Process, Planning Process History, Fiscal Year (FY) 2024/2025 Planning Process, Potential Gaps in Goals, and Challenges & Opportunities (Stakeholder Input).

Chair Truex commented on Quality of Life Scorecard, citizen surveys, local governments, agencies, federal dollars, resiliency, costs, future projects, Department Directors, inflation, community rebuilding, resale values, effects, affordable and workforce housing, City of North Port, septic to sewer, and needs. Commissioner Constance discussed Quality of Life Scorecard, citizen surveys, funding, allocation, grants, projects, local governments, agencies, Bermont Road, State roads, Department Directors, traffic, Interstate 75 (I-75), infrastructure, growth, technology, West Port, and Babcock Ranch. Commissioner Tiseo spoke to projects, funding, agencies, Bermont Road, traffic, congestion, Lee County, affordable and workforce housing, Sadowski Trust Fund, and infrastructure.

Assistant County Administrator Claire Jubb gave a brief overview of Resiliency, Resiliency in Charlotte County, Bold Goal – Efficient and Effective Government, and Long-Term Recovery.

Deputy County Administrator Emily Lewis interjected on Harborview Road, mitigation funding, staffing needs, and federal grant process.

Dr. Marlowe responded to resiliency, changes, adaptation, demographics, growth, affordable and workforce housing, services, and gave a brief overview of Resiliency and Re-generativity, The 3 levels of organizational resilience, Operational Capacity, Scenario Planning & Processes, Culture, and Developing a Resiliency Plan.

County Administrator Flores remarked on meetings and projects.
