BOARD OF COUNTY COMMISSIONERS

MAY 21, 2024

A Strategic Focus Area Updates Workshop was held at the Murdock Administration Complex in Commission Chambers; Room 119, Port Charlotte, Florida.

The following members were present: Chair Truex (arrived at 3:18 pm), Commissioner Constance, Commissioner Deutsch, Commissioner Doherty, and Commissioner Tiseo. Also in attendance were: County Administrator Flores, County Attorney Knowlton, and Minutes Clerk Welsh. The following members were absent: None.

The Meeting was called to order at 3:00 pm, followed by the Pledge of Allegiance.

County Administrator Flores highlighted Strategic Focus Area Updates Workshop.

1. Strategic Plan
