# FHFC RFA 2022-206 HOME Financing to Be Used for Rental Developments in Certain Hurricane Ian Impacted Counties

Colleen gave an overview of the RFA and special provisions for proposed developments in Charlotte County to access state bonds and non-competitive tax credits (4%/SAIL) to increase number of units and per unit development costs. It was suggested that staff reach out to Blue Sky developer to inquire about the feasibility of Jacaranda Terrace for this RFA.

#### **Charlotte HOME**

**Verandas III** – Developer terms were presented to the BOCC and staff were directed to address several items and negotiate suggested terms for reconsideration. Underway. **Vincentian Villas** – St. Vincent DePaul Cares' application for FHFC's RFA 2022-209 for HOME ARP funds was not selected. They intend to resubmit for RFA 2023-102 SAIL Financing For Smaller Permanent Supportive Housing Developments For Persons With Special Needs, issued in December 2022. There was discussion about keeping the

\$650,000 in subsidies obligated until the outcome of this RFA.

\*Motion to obligate Charlotte HOME subsidies for Vincentian Villas up to \$650,000 through February 2023 (revisit at February AHAC meeting), Kurt Pentelecuc. Second, Mike Mansfield. **Motion passed.** 

**LGAO** – RFA issued 10.24.2022. One application received by 11.08.2022 deadline. Vesta Esperanza Village is a proposed 72-unit affordable development presented by Newstar and Middleburg Development. AHAC and Charlotte HOME review committee members individually reviewed/scored the proposal for a cumulative score of 101 points.

\*Motion to recommend Vesta Esperanza Village for selection for LGAO 2022 local preference, local government contribution of \$340,000 contingent upon award of 9% LIHTC, and consideration of incentives and maximum Tier IV subsidy totaling \$464,272, Mike Mansfield. Second, Michael Meagher. **Motion passed.** 

#### **SHIP Funding Update**

- SHIP-DR for insurance deductibles a program update was provided/discussed.
- Prioritization of unencumbered SHIP funds a review of unencumbered SHIP funding through FY23 was conducted and discussion of priorities ensued with the following outcome:
  - \$572,000 SHIP-DR for insurance deductibles (no additional SHIP funds)
  - \$360,000 for Rapid Re-Housing
  - o \$1.5M for Rental Rehabilitation RFA
  - \$400,000 for Disaster Assistance and Emergency Repairs
  - o \$500,000 for Purchase Assistance and Owner-Occupied Rehab
  - \$250,000 for Demolition/Reconstruction

**Real Estate** – Lynn updated on rentals in the inventory (few to be had) and increases in rent; she also cited a Landlord Subsidy offered in Coral Springs/Broward Co. for review.
