Qualification Requirements

- Must be a Charlotte County Resident
- Must be employed part time (20 hours per week or more) or attending school part time (verification required)

Required Documentation

- Completed Scholarship Application
- Proof of residency (water bill / electric bill / lease) only 1 needed
- Copies of Birth Certificates for ALL children in the household
- Proof of Employment for ALL adults in the household (last 2 pay stubs)
- 2022 Tax Return (taxes you filed this year)
- Proof of College Enrollment (print out of class schedule)
- Proof of all other income including: child support, alimony, SS, TANF, and income for all other working adults in the household

All required documentation is needed in order for your application to be reviewed. **Incomplete applications will not be accepted.** If you do not meet the “Qualification Requirements” you are not eligible for scholarship. Scholarship eligibility is based on the amount of family members in the household and the amount of income earned. If you falsify your application or withhold income information Charlotte County reserves the right to revoke your scholarship funding and charge your account the full price for summer camp, which is required to be paid in full before your child/children will be permitted to return to the program. Scholarship is awarded on a first come first serve basis and covers 50% of your total cost for camp. Any further questions should be directed to Recreation Supervisor Leah Williams at 941.613.3230.
